Areas of Legal Practice Tennessee Traffic Court Violations

Tennessee Traffic Ticket - Tennessee Speeding Ticket

Tennessee Traffic citations, including speeding tickets and traffic tickets, may be issued instead of arresting a defendant for minor driving violations, usually for those involving an automobile.

Speeding tickets are the most common example of traffic tickets or traffic court citations in Tennessee, and other examples include Failure to Yield, Following Too Closely, and Disregarding a Traffic Signal. A citation may also be issued for Underage Possession or Consumption of Alcohol, Simple Possession of Drugs, or other misdemeanor offenses.

Traffic tickets, speeding tickets and other traffic related citations are usually heard in either General Sessions Court or Municipal Court. The following are consequences which may occur if you are convicted of, or fail to satisfy, a traffic citation in Tennessee:

- A fine and/or court costs.
- Probation.
- Points added to your driving history.
- Tennessee driver's license revocation or suspension.
- Increased car or auto insurance premiums.

However, Mr. Oberman and Ms. Compher-Rice can often assist you with resolving a Tennessee traffic ticket, Tennessee speeding ticket or Tennessee traffic citation in such a way that many of these circumstances may be avoided. Because the facts, law, and circumstances of each Tennessee traffic ticket case vary, it is important for persons in need of a lawyer to meet individually with counsel to obtain specific advice about traffic courts in Tennessee. The information contained on this website regarding Tennessee traffic tickets, speeding tickets, and traffic citations is no substitute for individual legal consultation.

Why not just pay the Tennessee traffic citation?

If you mail in a Tennessee traffic ticket or speeding ticket payment, you will automatically be convicted of the traffic ticket offense and face the consequences of such conviction, such as points being applied on your driving history and increased auto insurance or car insurance coverage costs.

Out of State License

Tennessee will report all convictions for traffic citations, including speeding tickets, to your home state. Therefore, you should consult the Tennessee Department of Safety, the equivalent agency in your home state, or a local attorney to determine the exact consequences your Tennessee traffic ticket or Tennessee speeding ticket may have on the status of your driver's license. For instance, in some states, your driver's license could be suspended if you are convicted of excessive speeding (i.e. 20+ MPH over the posted speed limit).

What information will I need when contacting your law office in Knoxville, Tennessee about my traffic ticket or speeding ticket?

- The color of the Tennessee traffic citation (this helps us determine to which traffic court you have been cited);
- The Tennessee speeding ticket or Tennessee traffic ticket citation number (located in the upper right hand corner of the traffic citation);
- Date of traffic citation (usually located toward the bottom of the traffic ticket or speeding ticket);
- Traffic Court date (usually located toward bottom of the traffic ticket or speeding ticket, just below the date of the traffic citation);
- Name of Tennessee police officer (if legible); and
- The charges listed on Tennessee traffic ticket or citation (usually located in the middle of a speeding ticket in the narrative section).

Tennessee Traffic Ticket and Speeding Ticket Myths

My state will not find out about my traffic ticket or speeding ticket conviction received in the state of Tennessee. False. Any Tennessee traffic conviction will be reported to your home state.

If I complete driving school, my Tennessee traffic ticket or speeding ticket citation will automatically be dismissed.

False. Tennessee traffic ticket or speeding ticket dismissals are granted on an individual basis and can only be granted by the Judge.

It's less expensive for me to just pay the traffic ticket than to hire a Tennessee traffic court lawyer or speeding ticket attorney. False. In the long run, it is often more expensive to pay the traffic ticket because of the increase in car insurance premiums and other collateral consequences, especially in cases involving a speeding ticket.

I'm unable to appear on my court date, so my only choice is to pay the Tennessee traffic ticket or Tennessee speeding ticket citation.

False. Depending on the facts of your traffic court case, your traffic court lawyer or speeding ticket attorney may be able to waive your appearance or postpone your speeding ticket or traffic ticket case.

Tennessee Department of Safety Traffic Violation Points

The Tennessee Department of Safety may suspend your Tennessee

driver's license if you accumulate twelve (12) or more points within a one (1) year period. A Tennessee licensee is entitled to a hearing before your driver's license is suspended; however, you must request a hearing within a specified period of time.
